Europe is emerging as real weak link for world economy

Paris, February 13 Industrial production across the 19-nation euro area is falling at the fastest pace since the financial crisis, and deteriorating demand is evident as the region finds itself squeezed between international and domestic drags. That leaves expansion at risk of barely topping 1% this year, a sharp slowdown from 2018, with even continental powerhouse Germany in trouble. Investors are tuning in. The Bloomberg euro index is near its lowest since mid-2017, and European stocks have never been cheaper relative to bonds in terms of yield gap. "The concern I have right now is in Europe," said Salman Ahmed, chief investment strategist at Lombard Odier. "It's clear China is going through a slowdown, but there's also a strong amount of stimulus in the pipeline. However, in Europe, things are deteriorating quite fast." The extent and surprising suddenness of the weakness reflects that the slowdown is hitting the core of the region. While the likes of Greece were at the root of past sluggishness, this time Germany's prospects are crumbling after a protracted slump in manufacturing. Household spending has also ground to a halt in France, which is beset by the Yellow Vest protests. Together, those two countries account for about half the euro-area economy. —BLOOMBERG
